Rules Applying to Dog Shows

Effective January1, 2010

Chapter 11, Section 1

No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class, unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration.

Notice to dog owners/exhibitors :

When you sign the show entry form, you automatically agree to the following terms concerning motels. They have been established for the good of all exhibitors and will ensure future use of these facilities.

Rules at the Host Hotels:

1. Maximum 4 dogs per room
2. **Hotels will provide plastic sheeting for under dog crates and a special door hanger for rooms with dogs.**
3. Dogs left unattended in room must be crated with the plastic sheeting under crates Hotel guests with dogs in room must use the special door hanger provided by the hotel. This hanger will leave instructions to the housekeeping staff. Housekeeping will not enter the room unless door hanger is present.
4. Housekeeping must be allowed to clean a guest room (with dogs) at least every two days. Guests who have special request (i.e. a certain time of day that room will be vacant) can discuss them with the housekeeping staff upon arrival.
5. Bathing and/or grooming of dogs in or right outside the guest rooms is NOT allowed. The hotel will impose a \$100.00 penalty to anyone found grooming in this manner. The hotel has provided a grooming house on the grounds which will be available. Grooming is not allowed on any sidewalks.
6. Owner/exhibitors should bring their own toweling for bathing dogs. A daily inventory for missing or damaged towels will be taken and any necessary charges will be applied to guests.
7. Dogs must be kept on a leash at all times while out of the guest room.
8. Dogs should be exercised in designated areas on the motel premises. Every dog owner is expected to pick up after their own dog and dispose of waste in designated receptacles. It is the responsibility of the dog owners to find out from the motel staff where these areas and receptacles are located.
9. The hotel and the show committee will investigate any problem areas that are outlined above. Any guest not following the above guidelines will be asked to check out of the hotel without refund. The Show committee will make a report to the AKC
10. Rooms will be inspected daily by members of the motel staff and observed violations or damages will be reported to the motel management and/or the show committee. The show committee, working with a fair and equitable system, is charged with investigating complaints. Each dog owner/exhibitor is expected to cooperate with the investigative committee if a complaint is filed.
11. Flash photography is not permitted ringside.
12. Cell phones must be turned off or on vibrate at ringsides. Please leave area to use cell phone.
13. No smoking indoors or within 25 feet of any performance trial ring or doors.

NOTICE TO EXHIBITORS



The AKC will collect a \$3.00 AKC Recording Fee for each entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees will be collected on each entry.

- Please note: Rally is considered a separate trial from obedience.
At every licensed or member club Rally Trial, a Recording Fee of \$3.00 shall be required for the entry of each dog.
A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
Canadian Exhibitors must submit entries with checks drawn on U.S. Accounts or with international money orders in U.S. funds.
Dogs need be present only for scheduled judging and will be released if not needed for further judging.
Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or agents of Class Judging.
No Entry will be accepted which specifies any condition as to its acceptance.
Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly.
Returned checks do not constitute a valid entry fee.
Refunds for cancellations due to judge change or cancellation made prior to entries closing will be mailed to said exhibitor or agent after the show.
Entries will be acknowledged after entries close with entry acknowledgement and judging program to address on entry.
Loss or Damage: The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune to either dogs or exhibitors participating in these shows.

Best All Around Sheltie

To be eligible for this award, dogs must compete in three of five events. Advance registration is required. Entry should be made on the separate registration form for this competition. Point values will be assigned to entrants in competition as follows:

Table with 2 columns: Breed and Obedience or Rally. Rows include participation, make a cut, place 1-4 in a class, RW, Winners, BOB, BOS, AOM, and Agility/Herding categories.

BONUS 1 pt for a dog who competes in all five venues

Dogs receiving qualifying scores in performance events will be awarded 2, 3, or 4 points as appropriate for their class, but do not receive the participation point as well. The participation point in performance events is awarded only if the dog competes but does not qualify in the event.

Dogs who make a cut or earn placements and awards in breed competition will be awarded 2, 3, or 4 points as applicable to the award, but do not receive the participation point as well. Dogs who make multiple cuts in a class will receive the same two points as dogs who make one cut.

The official catalog markings taken from the judges' books for each event shall be used to determine eligibility, participation, placements and official scores.

Agility Trial Prizes and Awards

Ribbons: Rosettes will be awarded to the first through fourth place dogs in each jump height in each class. Qualifying ribbons will be awarded to each dog receiving a qualifying score. There will be MACH and Double Q Ribbons for Excellent B exhibitors who qualify for them.

Trophies: Trophies will be awarded to 1st through 4th places in the Standard and JWW classes (including Preferred) as follows:

1st Place through 4th place ASSA Engraved Silver plates in graduated sizes.

Rosettes and trophies will be awarded to the High Scoring Novice Dog, High Scoring Open Dog and High Scoring Excellent Dog. Method for determining High Scoring Dogs for each class will be from the regular STANDARD class only. (**Preferred classes not eligible**).

Trophies for each of the High Scoring Dogs..... Silver Platter

- High Score in each of the classes is first determined by score and then the fastest yards per second in the Standard run
- For the purpose of this award, the Novice A & B will be considered one class. Excellent A & B will be considered one class.
- All runs must be qualifying runs.

- The safety of dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are able to perform all obstacles safely. Ring size will be 100 x 100. Agility will be indoors in the Purina Farms indoor course on composite rubber matting.
- Conditional, unsigned, incomplete, telephone or telegraph entries cannot be accepted. Entries must be on Official AKC Entry forms or photocopy with agreement and rules on back.
- Express mail entries must include signature permitting them to be left at the secretary's address without recipient's signature.
- Owners are responsible for all errors on entry forms and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.
- Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by action of the trial committee. Dogs Eligible to Enter

A maximum of 10 entries per envelope is allowed. Envelopes with more than 10 entries and/or entries received prior to the opening date will be returned.

Must be delivered by a multi-state or multi-national postal or carrier service, including, but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.

This trial is open to **Shetland Sheepdogs only** over the age of 15 months that are registered with the American Kennel Club or that have AKC ILP/ PAL numbers. Bitches in season may not compete. No refund for bitches in season.
